



***Are there any prerequisites for enrolling?***

*No, CAFS was developed for movement professionals from all industries and from all levels.*

***How long is CAFS?***

*CAFS contains around 25 hours' worth of content broken down by modules and sub-sections. CAFS is completely self-paced so overall completion times will vary from person to person.*

***Is there a start date?***

*CAFS is completely online and self-paced so you can start and finish at your own pace.*

***Is there a live component?***

***How will I be tested?***

*Throughout the CAFS you will be required to periodically take an exam before moving onto the next section. Since you will be tested throughout the certification there will not be one lengthy final exam.*

***Is there a time period for me to finish?***

*Once you purchase CAFS you will have access to the material for 3 years. You can complete the course at any time in that three years period. Even after you finish the certification you can still go back and review the content as often as you'd like in that 3 year period.*

***Will CAFS require me to maintain my certification?***

*CAFS is a one-time certification that requires no continuing education.*

***Will there be ongoing support for CAFS?***

*Yes, you will have two options. One, the faculty and staff at the Gray Institute are always here to serve you and answer questions. Two, there are over 450 GIFT Graduates located throughout the world which you can find from our locator (might even be one in your area).*



***Is CAFS approved for CEU's or CEC's?***

***Is CAFS approved for CEU's or CEC's? (Chiropractors)***

***Will I receive a certificate of completion?***

*Yes, you will receive a customized certificate once you have completed the content and passed all exams. This Certificate will be available on the main CAFS page of your account.*
